#### 3. Announcements

Claire announced she visited "Jimmy Joe's Garden" at North Beach and spoke with Jimmy Joe about progress of the garden, and how wonderful it is.

### 5. Approval of Minutes

# 6. Staff Updates

- a. Mohsen reported that the missing "Welcome to the Kid Friendly Zone. No Pets Allowed" signs near the Tot Lot have been replaced.
- b. Resident Tyden Chinowsky gave a PowerPoint presentation on his offer to help save the Torrey Pines trees of Anderson Canyon, demonstrating the beneficial consequences of having a healthy Torrey forest locally. Tyden's project would involve removing non-native plants including ice plant, and replacing those plants with California natives. The presentation was very favorably received. Jack recommended that Tyden report back to P&RC with a specific plan, showing the exact location, and the plants and trees anticipated to be planted. Jack also asked that Tyden set the scope of the project to include only a few trees and plants, so as to be very attainable.

# 7. Committee Reports / Actions

a. Scripps Bluff Preserve.

**ACTION:** P&RC after discussion, motion, second, voted unanimously to approve the Planning Dept.'s Draft "Goals, Policies and Standards" for Scripps Bluff Preserve, as presented by Matt Bator, **provided** the draft Regulations include a statement that alcohol and smoking and vaping materials are banned from the Preserve.

Claire reported that the work to create content for the web page has been going slowly but surely.

# c. Advisory Committee and Liaison Operating Procedures

Dwight presented an overview of both the operations of the Advisory Committee and the role of the Council Liaisons.
