Members must be a registered voter in Del Mar and shall serve without compensation.

<sup>2</sup> The Planning Commission shall perform such duties as may be specified by ordinance or resolution of the City Council or by law. Further, the Planning Commission shall study and report to the City Council upon any matter referred to it for such action by the City Council, and shall keep the City Council currently advised of all matters pending, and shall furnish any specific information, reports or materials which the City Council may request. The Planning Commission shall consist of five members who shall be qualified electors of the City. Members of the Planning Commission must be registered voters in Del Mar and shall receive no compensation for their services.
